

***NABA, Inc. iPad® and Wii™ Sweepstakes Terms and Conditions**

Prize 1: A single winner will receive one (1) Black 16 GB iPad® 2 with Wi-Fi connectivity.

Prize 2: A single winner will receive one (1) Black Wii™ Gaming Console.
